4. **Earnest Money Deposit:** - The interested firms are required to deposit Earnest Money Deposit (EMD) of five percent on the quoted price of Change Management work in the form of Account Payee Demand Draft, Fixed deposit receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks in favour of "Sr. Accounts Officer (Administration), Office of the Principal Accountant General (A&E), Nagaland, Kohima".

The Earnest Money Deposit (EMD), without any interest accrued will be refunded as follows:

- a. EMD of those firms not qualified for awarding Change management work will be refunded on or before 30th day after award of the work.
- b. EMD of successful firm will be refunded only after completion of Change Management work.

- ii. All payments will be released based on the rates quoted in the quotation received and invoices submitted to this office.

A certificate on the company's letter-head stating that the bidder has not been blacklisted by any institution/organization/society/Central/State Government/Ministry /Department or its public sector organization, with company stamp and signed by authorized signatory should also be submitted.

- iv. If the bids are not accompanied by all the requisite supporting documents, the same would be rejected.
